## Get Money Back On Your Home

North Carolina's Elderly or Disabled Exclusion program provides property tax relief for qualifying homeowners at least 65 years of age or those totally and permanently disabled. The Disabled Veteran Exclusion program has no age or income limitation and provides relief specifically for disabled veterans, and the surviving spouses (who have not remarried) of servicemembers or veterans.

AARP Foundation Property Tax-Aide offers a free service for getting property tax relief in your community.

You could save money and get help staying in your home during these tough times.

A trained volunteer can determine if you meet eligibility requirements and help you apply.
